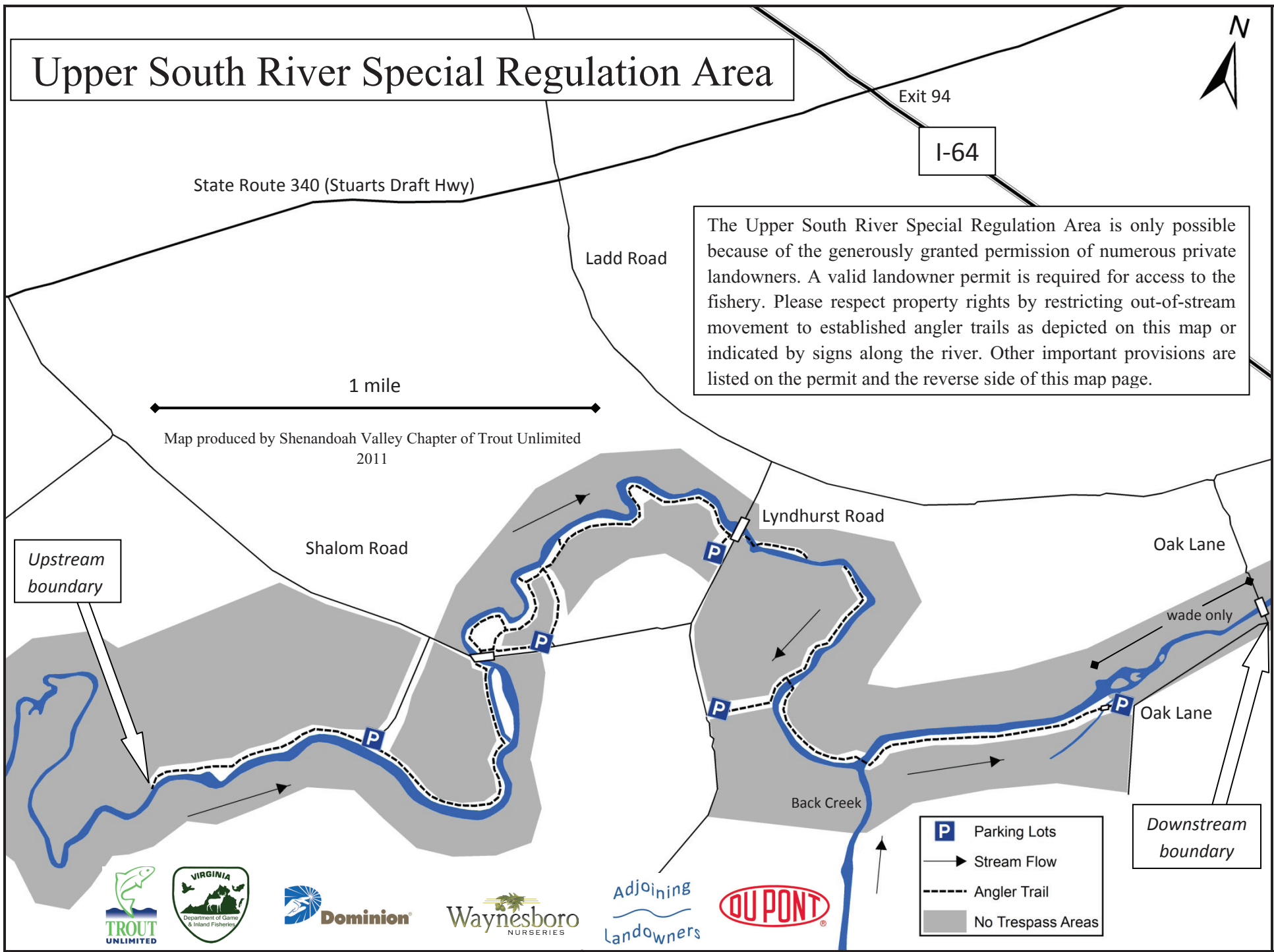

Upper South River Special Regulation Area

Regulations of the Virginia Department of Game and Inland Fisheries

- Only single hook artificial lures maybe used.
- No bait may be in possession while fishing these waters.
- Creel limit is two (2) fish per day.
- All trout less than sixteen (16) inches in length must be immediately returned unharmed to the water.
No trout less than sixteen (16) inches may be in possession while fishing these waters.
- A valid landowner permit must be in your possession while fishing these waters.*

Requirements of Adjacent Landowners

- A valid landowner permit must be in your possession while fishing these waters.*
- Access must be via designated parking areas, established and marked Angler Trails, and designated and marked access points.
- Angling should be primarily by wading; bank-side movement is restricted to no more than 30 feet from the river's edge.
- No camping, picnicking, or fires allowed. No dogs, No firearms, No alcoholic beverages.
